I understand the following conditions apply to mutual exchange.

1. Cunninghame Housing Association Limited has its own mutual exchange policy and its own reasons for refusing mutual exchanges. You should check with your own landlord what their policy is.
2. I need to inspect the house that I want to exchange into and make sure it is in an acceptable condition and that all fixtures and fittings etc are left intact.
3. Cunninghame Housing Association Limited will not incur any expenses in connection with a mutual exchange other than normal repairs, which are the landlord's responsibility.
4. My house will be inspected by Cunninghame Housing Association Limited and any repairs identified as being a result of my carelessness or negligence will need to be repaired at my expense prior to the exchange being approved.
5. Cunninghame Housing Association Limited is not responsible for the maintenance of any non-standard fixture or fitting that the incoming tenant wants to keep.
6. I understand that if this mutual exchange is granted I will have a Modernised Right to Buy. The Association has been granted a 10 year exemption period which runs until the 30 September 2022 and the Association may apply for further extensions beyond this period.

I understand that if this mutual exchange is granted and I am moving to a property acquired or built by the Association after the 1 March 2011 I will have no right to buy.
